

Categories of acceptable certifiers

The certification must have been carried out no more than three months prior to the date the certified copy is presented.

If the certifier is not a member of HSBC NZ staff, they must be at least 16 years of age and one of the following:

- 1 Notary public
- 2 Justice of the Peace
- 3 New Zealand Honorary consul
- 4 Lawyer (as defined in the Lawyers and Conveyancers Act 2006)
- 5 Chartered accountant (within the meaning of Section 19 of the New Zealand Institute of Chartered Accountants Act 1996).

In addition, the certifier must not be:

- related to the customer ;
- the spouse or partner of the customer; or
- a person who lives at the same address as the customer.

Identification and Address Verification Documentation

Identification Documentation

All individuals (ie personal customers and associated parties) are required to provide identity verification to confirm their full name, date of birth, nationality and identity document type and number.

Individuals must provide:

- A Passport and one form of ID from Category A, B or C

Category A - Primary photo ID

- National Identity Card issued by government

Category B - Primary Non-Photo ID

- Birth Certificate
- Citizenship Certificate

Category C - Secondary ID

- Driver Licence (with photo)
- NZ Firearms Licence
- Bank Card issued by a financial institution with name embossed and signature such as ATM Card and Credit Card

Address Verification Documentation

Where address verification is required, please provide one of the documents dated **no more than three months** from the list below:

- Utility Bills (eg electricity/gas bill, Sky TV bill, phone bills – mobile (on plan) or home line, local council rates bill);
- IRD Tax Assessment Notice (New Zealand);
- Credit Card/Bank Statements from an active (not closed) account. Please note that an e-statement cannot be used for address verification;
- Government Valuation on property;
- Letter from a New Zealand employer on the employer's letterhead;
- Tenancy Agreement for a New Zealand address; and
- Australian Driver's Licence.
